Senior	25	22	Allows entry into all applicable events
Junior/Cadet	15	13	Allows entry into all applicable events
U12	10	8	Allows entry into all applicable events
U10	Free	Free	New Category – Allows entry into all applicable events
Over 65	10	8	Gives all rights of full membership
League players	15	13	Allows members to play in their affiliated league and to also enter participation events in their own province. (Participation includes National Team Tournament and banded tournaments below the open draw level).
Unemployed	Free	Free	Applicable to Senior members who are unemployed or other members where the main earner in the household is unemployed.
Coach / Official	10	8	Applies if member is “non playing” but is acting in an official capacity for a club , school or the ITTA e.g. Club Leader , Club Secretary etc

Notes:

1. If an existing member introduces a new fee paying member then the existing member shall get a 50% rebate on their membership.
2. Affiliations to be collected through the Branches and an administration Fee of 10% of amounts collected to be paid by the ITTA to the Branches after receipt by ITTA of the amount collected. Full information on all members must be submitted in order to qualify for the grant. Members are entitled to affiliate directly through the ITTA if they wish but the preference is for affiliation through the local Branch.
3. The unemployed category is “self appraised” i.e. a member declares themselves unemployed when submitting the form, however if during the course of the year the member is successful in gaining employment it would be expected that they change their category and pay the appropriate amount.
4. **Affiliation Period is from January 1st 2010 to December 31st 2010**
5. **Fees are due by 31st December 2009.**
